

<b>Contest Rules and Regulations</b>	
<b>Organiser and Eligibility</b>	
1	The PERADUAN TESCO SUPERMARKET SWEEP [“Contest”] is organised by Nestlé Products Sdn. Bhd. [45229-H] [“the Organiser”] and is open to all legal residents of Malaysia aged 18 years and above as of 08/12/2016 [each a “Participant” and collectively, the “Participants”]. The Organiser reserves the right to request for identification document as proof and for purposes of verifying the identity of a Participant.
2	The following persons are not eligible to participate in the Contest:
[a]	Employees of the Organiser [including its affiliated and related companies] and their immediate family members [spouse, children, parents, siblings (and their spouses)]; and/or
[b]	Representatives, employees, servants and/or agents of advertising and/or promotion service providers of the Organiser [including their affiliated and related companies], and their immediate family members [spouse, children, parents, siblings (and their spouses)].
3.	The Organiser shall reserve the right to exclude and/or disqualify Participants who do not fall within the category of Participants and/or who are in breach of the Contest Rules and Regulations.

<b>Duration</b>	
1	The Contest will run from 08/12/2016 to 01/02/2017 [“the Contest Period”]. The Organiser shall reserve the right at its absolute discretion to vary, postpone, re-schedule and/or extend the Contest Period and/or cancel/terminate the Contest at any time without prior notice. All entries received outside the Contest Period will be automatically disqualified.

<b>Qualifying Criteria and Submission of Entries Via WhatsApp Application</b>	
1	To participate in the Contest, Participants must purchase a minimum of Ringgit Malaysia Thirty Eight [RM38] of any participating NESTLÉ products <b>EXCEPT</b> all NESTLÉ infant formulas and Dolce Gusto products, in a single printed receipt from any participating TESCO outlets during the Contest Period. The original TESCO single printed receipt must contain the NESTLÉ participating products purchased, the purchase amount, the outlet name, the receipt number and the date of purchase clearly stated on the printed receipt [“POP”].
2	All Contest entries must be submitted/sent via WhatsApp application from any locally registered mobile number to 016-7476813, a dedicated phone line set-up by the Organiser to receive entries submitted by Participants.
3	Each Contest entry must contain the key code – NESTLE, followed by [#], TESCO receipt number (full 16 digit number featured at the bottom of the TESCO receipt), followed by [#], full name, followed by [#], identification number followed by [#], NESTLÉ products purchase amount [“Required Details”]. The Required Details must be typed in one [1] single line and submitted/sent via WhatsApp to 016-7476813. WhatsApp example: <b>NESTLE#0504601817239603#LEE AH MOY#970101015202#RM41.20</b> Given that 016-7476813 is a dedicated phone line of the Organiser, <b>NO</b> acknowledgement messages will be sent by the Organiser in respect of all entries submitted/sent by the Participants to the Organiser via WhatsApp.
4	Each POP is eligible for one [1] WhatsApp entry only. Participants are not allowed to submit/send more than one [1] WhatsApp entry with the same POP to the Organiser. The Organiser shall have the right to disqualify and/or reject WhatsApp entries where:
[a]	the POP submitted is a duplicate, incorrect, unclear, torn or damaged; and/or
[b]	the Required Details are not provided, incomplete, illegible, unclear and/or inaccurate.
5	Each Participant is identified by the Required Details submitted in the WhatsApp entry.

<b>Prizes &amp; Winners Selection Process</b>	
1	During the Contest Period, the Organiser will give away eight [8] Grand Prizes and ten [10] Consolation Prizes.
2	As part of the winners selection process, the Organiser will allocate one [1] serial number for each entry received and approved by the Organiser to be a successful entry [each a “Qualified Entry” and collectively the “Qualified Entries”]. A set of serial numbers will be allocated for the Qualified Entries starting from serial number “1”.
3	The serial numbers allocated to each Qualified Entries will be tabulated and added up to derive the total

	number of Qualified Entries [“Total Qualified Entries”]. Assuming that the Total Qualified Entries throughout the Contest Period is <b>1889</b> , the Organiser will compute and shortlist Participants to win the prizes based on the following:
[a]	<p><b>Shortlisting of eight [8] Grand Prize Winners:</b>  <math>1889 \div 8 = \underline{236.1}</math>  Since dividing 1889 with 8 will result in a number with decimal value, the number 236.1 will be rounded down to 236. The following 8 Participants with Qualified Entries bearing the following serial numbers will be shortlisted to win the Grand Prizes: 236*, 472*, 708*, 944*, 1180, 1416, 1652, 1888.  [*computation example: <b>236</b>, <math>236+236=\underline{472}</math>, <math>472+236=\underline{708}</math>, <math>708+236=\underline{944}</math>].</p>
[b]	<p><b>Shortlisting of ten [10] Consolation Prize Winners:</b>  <math>1889 \div 10 = \underline{188.9}</math>  Since dividing 1889 with 10 will result in a number with decimal value, the number 188.9 will be rounded down to 188. The following 10 Participants with Qualified Entries bearing the following serial numbers will be shortlisted to win the Consolation Prizes: 188*,376*, 564*, 752*, 940,1128, 1316, 1504, 1692, 1880.  [*computation example: <b>188</b>, <math>188+188=\underline{376}</math>, <math>376+188=\underline{564}</math>, <math>564+188=\underline{752}</math>].</p>
4	The Organiser will contact all shortlisted Participants via the contact/mobile numbers from which the Organiser received the Qualified Entries. Each shortlisted Participant will be given one [1] question to answer. The Organiser will not be held liable in the event the shortlisted Participant[s] cannot be contacted for whatever reasons.
5	The shortlisted Participants must answer the question posted by the Organiser correctly in order to qualify for the next stage of the Contest. In the event any of the shortlisted Participants fails to answer the question correctly and/or clearly, then he/she shall be disqualified by the Organiser. The Participant holding the Qualified Entry bearing the serial number subsequent to the disqualified Participant shall be the next shortlisted Participant to be contacted by the Organiser.
6	Participants who have successfully answered the questions posted by the Organiser [“Qualified Participants”] shall be allowed to progress to the next stage of the Contest to participate in the TESCO Supermarket Sweep Challenge [“Challenge”]. The Organiser will further notify the Qualified Participants of the venue, date and time of the Challenge.
7	Participation by the Qualified Participants in the Challenge will further be subject to a set of terms and conditions [“Ground Rules”] that will be communicated and announced by the Organiser on the day of the Challenge to the Qualified Participants.
8	Subject to the Qualified Participants’ strict adherence to the Ground Rules set by the Organiser during the Challenge, each Qualified Participants in the relevant prize category are eligible to the following:
[a]	<b>Grand Prize:</b> Each Qualified Participant is entitled to “sweep” groceries worth up to a maximum of Ringgit Malaysia Three Thousand Eight Hundred and Eighty Eight [RM3,888] only.
[b]	<b>Consolation Prize:</b> Each Qualified Participant is entitled to “sweep” groceries worth up to a maximum of Ringgit Malaysia One Thousand Eight Hundred and Eighty Eight [RM1,888] only.
9	Qualified Participants who failed and/or refused to take part in the Challenge for whatever reason shall automatically be disqualified by the Organiser and prizes that have been allocated for the relevant Qualified Participant shall be forfeited by the Organiser.
10	The Qualified Participant’s right to participant in the Challenge is strictly non-transferable.

The Participant holding the Qualified Entry bearing the serial number subsequent to the Participant with repeat winnings shall be the next Participant to be shortlisted to take part in the Challenge where the allocated prize has a lower value.

Participants MUST keep the original POP submitted in the winning Qualified Entry for verification and participation in the Challenge purposes. 1	All Qualified Participants must abide by the terms set out herein including the terms attached to claiming the prizes/groceries, if any. Any and all prizes/grocery items which are lost and/or damaged for whatever reason are not replaceable and the Organiser disclaims any and all liabilities arising therefrom and the obligations to replace the lost and/or damaged prizes/grocery items.

1	The Organiser shall reserve the right at its absolute discretion to review and vary the Prize & Winners' selection process contained herein at any time without prior notice. The judges' decision is final and no correspondences thereafter will be entertained.
2	The Organiser shall reserve the right at its absolute discretion to substitute any of the Prizes with that of similar value, at any time without prior notice. The Prizes are non-transferable and all Prizes are given on an "as is" basis and are not exchangeable for cash, credit and other items or voucher in part or in full.
